setting forth the vessel's registration or documentation number, if any.

Boat Excise Tax bills are sent in the SPRING. If you do not put your boat in the water, if you sell or trade  
your boat, or if your boat is destroyed, please call the Assessor's Office at 617-846-2716.

FULL PAYMENT OF ANY BOAT EXCISE TAX AND WATERWAY FEE MUST BE MADE YEARLY  
IN ORDER TO RETAIN A VALID STICKER AND AVOID PENALTY OR VIOLATION.
